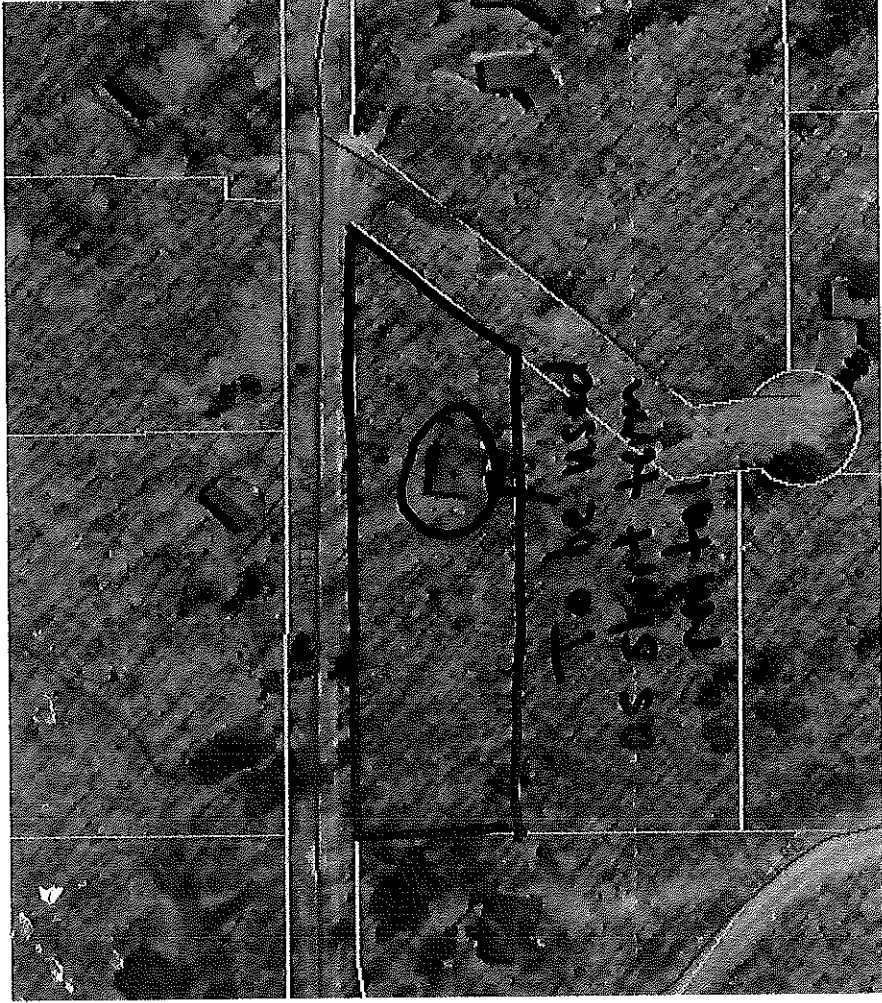

Selected point is located in the Bayfield/Penninsula/Southeast watershed within the Town of Bayfield and is found on the *Bayfield* USGS 7.5' quadrangle. It is zoned RRB (Residential-Recreational Busin). This district provides for permanent residential developments in neighborhood environments with water and/or sewer and other services/utilities. Such developments should be protected from traffic hazards and the intrusion of incompatible land uses. This location is within the Bayfield School District and is in Supervisory District 2.
