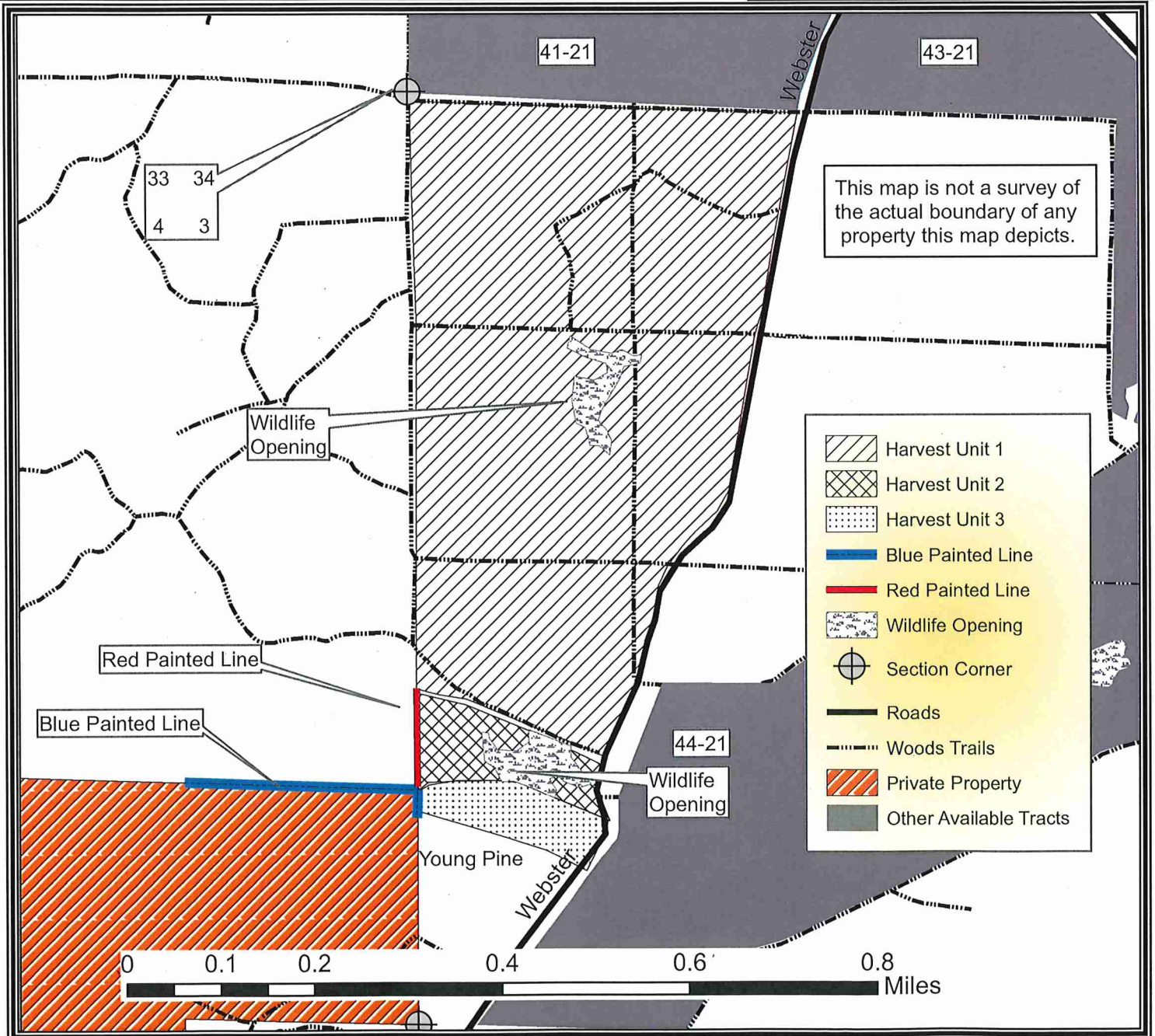

TRACT 42-21 – SUPPLEMENTAL REQUIREMENTS

The following terms and conditions supplement those provided in the Bayfield County Timber Sale Contract.

A. PRESCRIPTION:

1. Harvest Unit 1: has a third thinning prescription with an estimated average residual basal area of 80ft².
2. Harvest Unit 2: aspen coppice with reserves with an estimated average residual basal area of 4ft².
3. Harvest Unit 3: has a fourth thinning prescription with an estimated average residual basal area of 87ft².

B. HARVEST REQUIREMENTS:

1. Harvest Unit 1: harvest all orange marked trees and all aspen stems 2" or greater within the harvest unit. Leave and avoid damage to all unmarked pine trees and sub-merchantable trees within the areas labeled "Open Area" on the map.
2. Harvest Unit 2: harvest all aspen, red oak, and jack pine trees 4" or larger within harvest unit. Leave and avoid damage to all white oak and white birch within the harvest unit. Leave and avoid damage to all sub-merchantable trees within the areas labeled "Open Area" on the map.
3. Harvest Unit 3: harvest all orange marked trees. Leave and avoid damage to all unmarked trees.

C. OPERATIONAL REQUIREMENTS AND SEASONAL RESTRICTIONS:

1. Harvest Unit 1: sale boundaries consist of Webster Road, fuel break, young aspen, edge of plantations, and timber trails.
2. Harvest Unit 2: sale boundaries consist of Webster Road, timber trails, edge of plantation, red painted line, and blue painted line.
3. Harvest Unit 3: sale boundaries consist of Webster Road,
4. Within harvest unit 1 and 2 there are "Open Areas" marked on the map. Do not deck wood in these locations and avoid soil compaction in these areas.
5. Blue painted line indicates private property, no equipment or felled trees may cross this line.
6. If harvest will utilize the whole tree, 1 in 10 tops must be left scattered throughout the sale.
7. Harvested pine cannot be kept on the Bayfield County Forest for more than three weeks from May 1st to August 31st.
8. Do not cut snags except for individuals that pose a safety hazard.
9. Utilization specification is to a 4" top. However, if the County determines that pulpwood markets continue to be very poor at the time of harvest the County will sign a contract amendment with the purchaser changing the utilization specification to a 5" top for selected species. When determining condition of the market, the County will pay particular attention to the amount of wood being purchased by the mills in Wisconsin Rapids and any other significant shifts in wood demand.

D. ACCESS AND ROADS:

1. This contract requires County authorization for all road/landing construction and places a number of other requirements on road construction and closure.
2. Decking of wood along town roads will not be allowed without permission from Bayfield County.

E. OTHER:

1. To comply with Best Management Practices for Invasive Species: Prior to moving equipment onto or off the sale area, scrape or brush soil and debris from exterior surfaces to the extent practical.
