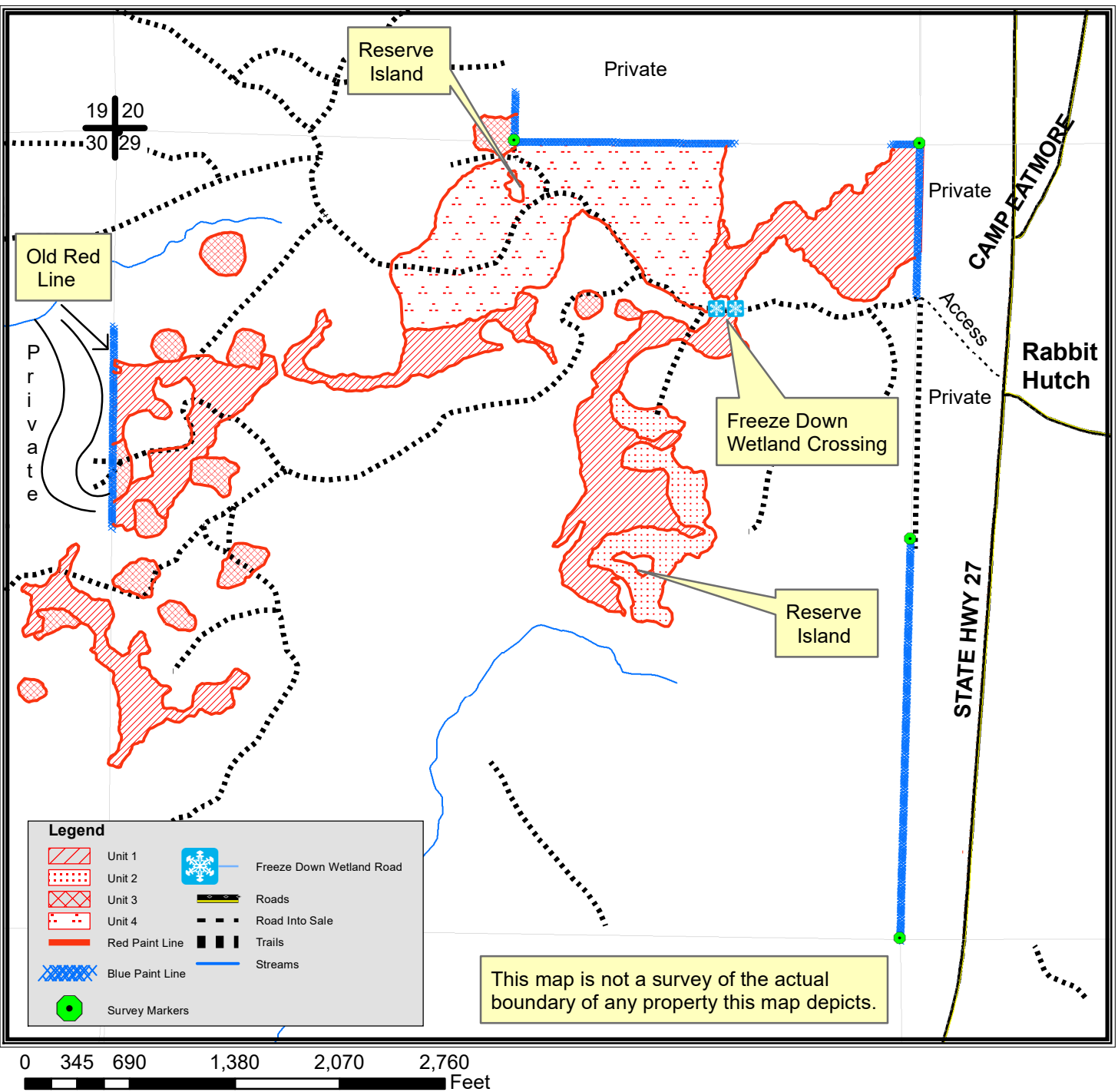

## TRACT 55-20 – SUPPLEMENTAL REQUIREMENTS

The following terms and conditions supplement those provided in the Bayfield County Timber Sale Contract.

### A. PRESCRIPTION:

- Harvest unit 1 has a swamp hardwood clear cut with reserves harvest prescription with an estimated average residual basal area of 44 ft<sup>2</sup>.
- Harvest unit 2 has a swamp hardwood coppice harvest prescription with an estimated average residual basal area of 4 ft<sup>2</sup>.
- Harvest unit 3 has a patch cut harvest prescription with an estimated average residual basal area of 0 ft<sup>2</sup> within the patches.
- Harvest unit 4 has an overstory removal harvest prescription with an estimated average residual basal area of 9 ft<sup>2</sup>.

### B. HARVEST REQUIREMENTS:

- In units 1 harvest all hardwood stems 8 inches and greater. Leave all conifers.
- In unit 2 harvest all hardwoods stems 2 inches and greater except white birch. Leave all conifers.
- In unit 3 harvest all hardwood stems (leave all conifers) 2 inches and greater within purple painted (2 dots facing in towards the patch cut and a purple slash facing away from the patch cut) boundary trees.
- In unit 4 harvest all hardwood stems greater than 6 inches except purple marked trees. Leave all conifers.

### C. HARVEST AND OPERATIONAL REQUIREMENTS AND SEASONAL RESTRICTIONS:

- Frozen ground operations only as determined by the county.
- An approximately 150' segment of road will require wetland freeze down crossing (see map).
- Wetland freeze down road to be made with minimal disturbance to soil. No fill into wetland.
- For unit 1 the ash harvest specification is currently, harvest all ash 8 inches at DBH and greater. However, if the contractor has good markets for ash pulp and desires to harvest ash less than 8 inches DBH, approval for this prescription change can be acquired from the County. If this occurs Bayfield County may negotiate a reduced stumpage rate in exchange for this additional utilization.
- Utilization specification is to a 4" top. However, if the County determines that pulpwood markets continue to be very poor at the time of harvest the County will sign a contract amendment with the purchaser changing the utilization specification to a 5" top for selected species. When determining condition of the market, the County will pay particular attention to the amount of wood being purchased by the mills in Wisconsin Rapids and any other significant shifts in wood demand.
- Sale boundaries include red paint line, blue paint line, and purple painted (2 dots facing in towards the patch cut and a purple slash facing away from the patch) boundary trees, see aerial map.
- The blue line indicates private property. No equipment or felled trees may cross the line.
- If harvest will utilize the whole tree, 1 in 10 tops must be left scattered throughout the sale.
- Do not damage any survey monumentation.

### D. ACCESS AND ROADS:

- Decking of wood along town roads will not be allowed without permission from Bayfield County.
- Access through sale in part runs through private property. Private access road must be returned to similar or better condition upon closeout.

### E. OTHER:

- This sale will be sold as a three (3) year contract. Contract extensions are not guaranteed.
- To comply with Best Management Practices for Invasive Species: Prior to moving equipment onto or off the sale area, scrape or brush soil and debris from exterior surfaces to the extent practical.
