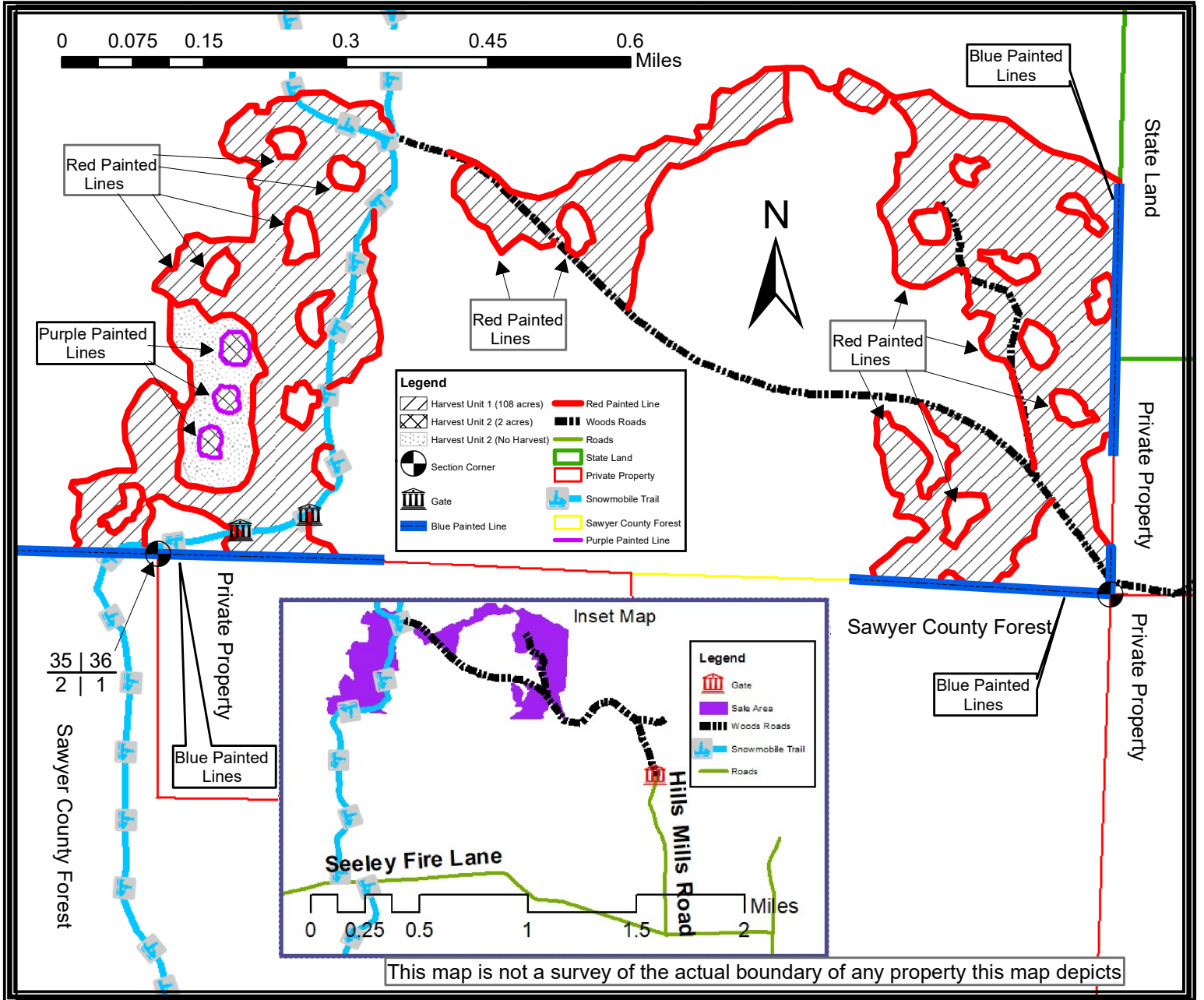

TRACT 49-22 – SUPPLEMENTAL REQUIREMENTS

The following terms and conditions supplement those provided in the Bayfield County Timber Sale Contract.

A. PRESCRIPTION:

- Harvest Unit 1: Northern Hardwood seed tree with reserve island (nineteen 1/8 -1-acre reserve islands spread throughout unit).
- Harvest Unit 2: Northern Hardwood gap selection (3 gaps, 0.5 acre each to be cut).

B. HARVEST REQUIREMENTS:

- Harvest Unit 1: Harvest all trees 4" or greater within the sale area.
- Harvest Unit 1: Reserve all conifer and red oak 20" or greater.
- Harvest Unit 2: There are three purple painted canopy gaps 0.5 acre each (8-10 marked trees with two purple dots facing the center of the patch along with panels on each side of the tree pointing towards the next purple boundary tree. There is a purple slash on the backside of each boundary tree which should help with navigating between gaps.) Harvest all merchantable trees and sever all trees 1" diameter and greater within the purple painted canopy gaps. Do not harvest any trees outside of patch and marked gap boundary trees.
- Leave all snags unless they pose a safety hazard.
- Sale may be harvested as round wood to a 4" top or whole-tree.

C. OPERATIONAL REQUIREMENTS AND SEASONAL RESTRICTIONS:

- Sale is being sold on a ticket scale basis.
- If harvest will utilize the whole tree, 1 in 10 < 4" diameter tops must be left scattered throughout the sale.
- Sale is bounded by red paint line, blue painted line, trails, and purple painted gaps.
- This sale is partially accessed via a snowmobile trail. During harvest operations the snowmobile trail must be kept unobstructed and in a packed snow condition. The purchaser to post appropriate signage along haul route and must ensure that harvesting and hauling operations will not create a safety hazard to snowmobiles. Avoid damage to all signs and trail markers.
- Excessive damage (beyond normal wear and tear) to the snowmobile trail, as determined by the county, will not be tolerated. If Bayfield County determines excessive damage has occurred, the Contractor may be held responsible for a portion or all of the repair. The County and Contractor must communicate on a regular basis to ensure issues are addressed in a timely manner and the snowmobile trail remains in a safe and acceptable condition.
- Utilization specification is to a 4" top. However, if the County determines that pulpwood markets continue to be very poor at the time of harvest the County will sign a contract amendment with the purchaser changing the utilization specification to a 5" top for selected species. When determining condition of the market, the County will pay particular attention to the amount of wood being purchased by the mills in Wisconsin Rapids and any other significant shifts in wood demand.
- The blue painted line indicates private property. No equipment or felled trees may cross the line.
- Do not damage any survey monumentation.
- This sale will be limited to frozen ground conditions as determined by the sale administrator.

D. ACCESS AND ROADS:

- This contract requires County authorization for all road/landing construction and places a number of other requirements on road construction and closure.
- Decking of wood along town roads will not be allowed without permission from Bayfield County.

E. OTHER:

- This sale will be sold as a three (3) year contract. Contact extensions are not guaranteed.
- To comply with best management practices for invasive species: Prior to moving equipment onto or off the sale area, scrape or brush soil and debris from exterior surfaces to the extent practical.
